Course Description

This is an introductory course in which we consider the basic ideas, structures, and political processes of the United States government, including the fundamental institutional relationships in the federal system. By the end of the semester, students should be able to recognize the major players in American politics, the basic structure of the U.S. Government, and the roles ideas, individuals, and institutions play.

In addition, we will apply these ideas in our discussion about the development of civil liberties and rights and the defining/protecting of these rights. Students will also be introduced to patterns in voter turnout and civic participation, as well as the role of public opinion and the media. Throughout the course, students are encouraged to bring up current events or issues that apply to our academic discussions in class.

I understand that with an online course, it may not be possible to meet me during my office hours or be on campus. I will be available by email during all normal business hours and will respond within 24 hours at the latest. You can email me at any time to set up a meeting in person. If you are on campus, and see my office in 470 CHSS open, feel free to stop by. Students are always welcome to drop in.

To aid in communication, I have set up a Slack channel for the course. Please go to [this link](#) and create an account using your SHSU email and name. I will have Slack up during most business hours, so students should be able to get in immediate touch with me during the session. It also contains channels where students can discuss with each other, help with assignments, post questions, or simply talk with other students.

1. Gaining a basic understanding of the subject (factual knowledge, principles, theories)
2. Gaining a broader understanding and appreciation of intellectual activity
3. Learning to apply course material to improve thinking and problem solving

You are free to purchase an older version of the textbook, but you will have to make sure you carefully keep track of assigned readings.

Each week, you will be assigned a series of questions about the week's readings. Responses should be at least one paragraph long, and address the question(s) asked in the prompt. They are due on the Sunday night before the start of the next week's material.

Exams will become available on midnight of the Friday they are assigned. You will have until 11:59pm the following Sunday to complete the exam. There is no time limit, but Blackboard tends to log inactive students out after 30 minutes so please save your answers frequently or navigate through the exam. Otherwise, Blackboard will log you out and lock the exam as incomplete.

Because this course is held entirely online, it is especially important to keep up with assigned reading. To help with this, I will post a brief outline every week outlining the learning objectives for the week and some important points. While you will still need to

read the text to succeed on quizzes and exams, this will help you narrow down your focus to do so more efficiently.

Because time is limited and there is a large amount of reading each week, exams will be open book and note. However, exam questions themselves will tend to ask you to apply, and identify examples, of terms and ideas discussed in the readings you will still need to have done the reading.

Student Absences on Religious Holy Days Policy:

Section 51.911(b) of the Texas Education Code requires that an institution of higher education excuse a student from attending classes or other required activities, including examinations, for the observance of a religious holy day, including travel for that purpose. Section 51.911 (a) (2) defines a religious holy day as: “a holy day observed by a religion whose places of worship are exempt from property taxation under Section 11.20....” A student whose absence is excused under this subsection may not be penalized for that absence and shall be allowed to take an examination or complete an assignment from which the student is excused within a reasonable time after the absence.

University policy 861001 provides the procedures to be followed by the student and instructor. A student desiring to absent himself/herself from a scheduled class in order to observe (a) religious holy day(s) shall present to each instructor involved a written statement concerning the religious holy day(s). The instructor will complete a form
